BOARD OF ADJUSTMENTS, PUBLIC HEARING AND REGULAR TOWN BOARD MEETING

The January 3, 2023, Board of Adjustment, Public Hearing and Regular Town Board Meeting opened with the Pledge of Allegiance and was called to order by Chairman Luedke.

The Board of Adjustments Public Hearing was called to order by Chair, John Mersberger.

The clerk read the notice to consider a Variance Request from Doug and Lisa Bocchini located at N7274 Birch Tree Road to reduce the centerline setback from 75 feet to 57 feet to allow them to extend their existing garage to make a handicap accessible bathroom and bedroom for their son, who is confined to a wheelchair. Doug and Lisa were both present. Doug explained that they plan to extend the existing garage by 24 feet and reusing the garage door that they have now so there would be no change in appearance to the home. They also explain that there still would be parking for approximately 6 cars in their driveway. The clerk received and read an email from a neighbor, Pete Tomchek, in favor of the variance and 2 other neighbors were present and were also in favor of it. A motion was made by John Capelle and seconded by Todd Vanderkin to approve the variance as presented. **Motion Carried 4-0**

The clerk read the notice to consider a Variance Request from Chet and Abby Gocha located at 2419 County Road PP to reduce the centerline setback from 100 feet to 92 feet and the side yard setback from 75 feet to 48 feet to be able to add a 10-foot by 16-foot prebuilt storage shed. There was discussion about placing the shed in different areas of the property, moving it back towards the house but there is a gas meter there and the code is that it must be 10 feet away. Dave Karsten and John Capelle would like it to be 100 feet off centerline from County Road PP but to move it 8 feet back the Gocha's would have to remove their fence and excavate, that could be costly. The house is only about 60 feet off County Road PP. The shed would be hidden behind a row of trees on the Pleasant View Rd side. After discussion, A motion was made by Jeff Rhude and seconded by Dave Karsten to approve the variance as presented. **Motion Carried 3-1**
